#### 3. Approve Extension of Tyler Tech Agreement.

Background Information: Ed Tech JPA awarded RFP No. 21/22-02 Human Resources and Substitute Management Systems to Tyler Technologies, Inc. (Tyler Tech") at the April 28, 2022 board meeting. The board approved one (1) year extensions on July 27, 2023 and June 27, 2024. Tyler Tech would like to extend the term of the current agreement for an additional one (1) year term, not to exceed five (5) years, in accordance with Education Code Section 17596.

**Recommendation:** Approve an amendment to the existing agreement with Tyler Tech to extend the term for an additional one (1) year.

## 4. Rescind Award to Open Text

**Background Information:** On February 29, 2024 Open Text Inc. (Open Text) was awarded RFP No. 23/24-04 Electronic Document Routing Solution, contingent upon successful contract negotiations. Contract negotiations have been slow and on August 25, 2025 Open Text notified Ed Tech JPA that they desire to withdraw their proposal.



Recommendation: Rescind award to Open Text.

## 5. Approve Amendment to Agreement and Pricing to the Kaltura Agreement.

Background Information: Ed Tech JPA awarded RFP No. 24/25-01 Media Asset Management Systems to Kaltura, Inc. (Kaltura) at the January 30, 2025 board meeting. The Master Agreement specifies Kaltura may add products introduced to the market that are either a direct replacement or are substantially equivalent to original products listed in the RFP, Kaltura's proposal, the Master Agreement and/or any Purchase Agreements or Added Products are enriched capabilities, new modules, technology advancements, and/or service categories within the solution that Kaltura did not have at the time the proposal was submitted.

**Recommendation:** Approve an amendment to the existing agreement to incorporate additional products and update pricing with Kaltura.

# 6. Approve Award of Bid No. 25/26-01 Technology Equipment: iOS and macOS to Apple Inc.. Background information:

Bid No. 25/26-01 Technology Equipment: iOS and macOS was advertised per Public Contracts Code on September 9 and 16, 2025. One vendor responded to the call for bids. Apple Inc. was determined to be the lowest priced responsive and responsible bidder.
